2. **Earnest Money Deposit:** The bid must be accompanied with E.M.D amount as specified against each work in shape of NSC/POTD/KVP/POSB/Fixed Deposit receipt of the scheduled commercial bank duly pledged in favour of BDO, KULIANA(CHANDUA).
3. **Sale and Receipt of Tender Paper:** The sale of the Bid documents will be made from the date of publication i.e. from dt:09 .01.2025 to 24.01.2025 up to 05.00 P.M.(on working days only). Bid should be received at the Office of the Block Development Officer, KULIANA(CHANDUA), Mayurbhanj, PIN-757014 through Speed post/Regd. Post only(No tender paper will be received by hand service) and superscribed as " NAME OF THE WORK" BID IDENTIFICATION NO-B.D.O, KULIANA(CHANDUA)-.(Written in Capital letter) on the Body of cover. The last date of receipt of the bid documents will be dt:24.01.2025 up to 05.00. P.M.
4. **Date of Opening of the tender Paper:** The Bids will open on Dt. 27.01.2025 at 11.00 A.M. at the Conference Hall, Panchayat Samiti, KULIANA(CHANDUA),MAYURBHANJ in the presence of the bidders who wish to attend. If the office happens to be closed (holiday) on the date of receipt/opening of the bids as specified, the bids will be received/opened on the next working day at the same time and venue without further notice. However, date of tender paper opening may be postponed as per the convenience of the authority by intimating all the concerned tenderers through notice affixed to notice board at Office of the Block Development Officer, KULIANA(CHANDUA),Mayurbhanj.
5. **Additional Performance Security Deposit:** Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tenders per works deptt. Letter No. 4710 .dt12.04.2022 In such an event, only the successful bidder who has quoted less bid price/rates than the estimate cost put to tender shall have to furnish the exact amount of differential cost i.e., Estimated cost put to tender minus the quoted amount as additional performance security (APS) in shape of N.S.C/K.V.P/Postal time deposit pass book/Term Deposit receipt duly pledged in favour of BDO, KULIANA(CHANDUA) within 7(seven) days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder.

6. **Performance Security Deposit:** Performance Security Deposit should be for an amount of 10% of the value of the contract from the successful bidder as per O.G.F.R Rule no. 213. Performance Security should be deposited in shape of N.S.C/Postal time deposit pass book/Term Deposit receipt duly pledged in favour of BDO, KULIANA(CHANDUA) at the time of agreement.
7. The following Documents should be furnished with the tender paper failing which the tender is liable for Rejection.
  - A) EMD Pledged in favour of BDO KULIANA(CHANDUA).
  - B) Self Attested copy of valid Contractor Registration Certificate.
  - C) Self Attested copy of valid Pan Card & GST Certificate.
  - D) SC/ST Contractors submit original Affidavit in support of cast certificate and attested copy Of Cast certificate.
  - E) Bank Draft towards cost of Tender paper in favour of BDO, KULIANA(CHANDUA).
  - F) P.H Contractor should submit original Affidavit in support of PH certificate regarding EMD Exemption.
  - G) An Affidavit in support of the authority of documents including no relation certificate should be attached with Tender Paper.
8. Engineering Contractors desiring to avail the exemption facility of EMD should submit an original affidavit as regards, the fact of availing award of work without submission of EMD/ISD during the current financial year. He should also produce original contract licence at the time of opening of tender document to make

necessary entry to that effect as such facilities are limited to three participation in tender during a financial year. Otherwise, their tender will be liable for rejection.

9. The SC/ST Contractors desirous of availing preference should submit an original affidavit in support of caste certificate and attested copy of caste certificate. Otherwise their tender will be liable for rejection.
10. G.S.T. as applicable shall be paid extra over and above the work value. The Contractor shall however be required to submit the TAX INVOICE along with the R.A. / final bill released of the G.S.T. amount by the department.
11. Shortfall of any required documents, Tender paper is liable for rejection.
12. A bidder can submit only one tender paper for a particular work. Submission of more than one tender paper by a bidder for a particular tender will liable for rejection of all such tender papers.
13. Other details can be seen in the bidding document.
14. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
