

The Authority reserves every right to reject any or all the Tender without assigning any reason thereof.





1. The Tender form along with terms and conditions can be obtained from the office of the Child Development Project Officer office hour can be downloaded from District. Web Site www.mayurbhanj.odisha.gov.in from Date. 13-01-2025 to Date. 22-01-2025. In case the application form is downloaded from website, the applicant shall furnish a Demand Draft of Rs. 1000/- (Rupees One Thousand) only (non refundable) towards the cost of application form along with the Tender paper from date 13-01-2025 to 22-01-2025. (Photo / flex copy of the FD will not be acceptable).
2. The paintings will be done as per specification given in Tender Form Part II. The colour of paintings will be made exactly as prototype. (For details one may contact office).
3. No Quotation will be entertained after the stipulated date and time.
4. The Quotationers have to be quote single rate of paintings and the price quoted must be inclusive of all taxes, transporting cost and other incidental charges if any. The rate quoted should be final and the quotation shall not be allowed to change the same in any circumstances.
5. The Quotation once submitted will not be returned back or exchanged.
6. Non-fulfilment of the aforesaid terms and Conditions will lead to non-acceptance of Quotation.
7. The successful Quotationers shall complete painting works within 2months from the date of receipt of the order,
8. Any Firm black listed by Central/State Government/ Board/ Corporation/ Autonomous body under Administrative control of Central/State Government etc. will not be entertained by the Tender Committee.
9. Payment will be made by the CDPO, KAPTIPADA after completion of paintings works subject to the submission of GPS photo Graph. The photo copy (soft copy) of painting will have to submit in the office of the CDPO, KAPTIPADA before claiming for payment.
10. The appearance of the paintings will be exactly as prototype. However, the Asian Paint should be used for painting work.
11. The approved Quotationer is required to submit Bank Statement or Passbook Copy of any Nationalised bank Account for easy transaction of payment for the painting works done by the approved quotationers
12. The Quotationer has to submit the following documents along with the quotation.
 - a) Self-attested copy of PAN Card.
 - b) Firm Registration Certificate.
 - c) Self-attested copy of valid GST Registration Certificate & GSTIN Number either in the name of Firm or its proprietor.
 - d) Minimum Three Wall Painting work experience in any Government Organisation (Work Order copy to be attached)
 - e) EMD (Security Deposit) of Rs. **30,000/-** in shape FD duly pledged in favor of CDPO, Kaptipada.
13. The bidder has Wall Painting experience in any 3 different departments under Govt. of Odisha.
14. The Bidder have completed district level Wall Painting projects under any two districts of Odisha.
15. The Bidder have to Submit all Wall painting Experience Documents along with a sample photo album of their accomplished wall painting projects.
16. Average annual turnovers more than Rs. 50,000/- (Fifty Thousand) for last 4 financial years.
