
- The following documents should be furnished along with the tender paper failing which the Tender is liable for rejection.
 - Self Attested copy of the Contractor Registration Certificate.
 - Self Attested copy of PAN CARD.
 - Money receipt of (Tender Paper) shall be enclosed in original.
 - Attested copy of Caste certificate for SC/ST Contractor desirous of availing preference.
 - Self Attested copy of active GST Registration Certificate of the bidder along with GST clearance Certificate.
- The Schedule Caste/Schedule Tribe/Physically handicapped Contractors desirous to avail the exemption of EMD and price preference (as applicable), should mention in the Affidavit.
- Clause No-36 if the rate quoted by the bidder is less than 15% of the tendered amount then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids, but if more than one bid is quoted at 14.99% (Decimals up to number will be taken for all particle purpose) less than the estimate cost, the tender accepting authority will finalize the tender through a transparent lottery system ,where all bidders/their authorized representatives and the concerned Block Development Officer /his authorized Officers will remain present.

N: B- If all the tender work will be not completed within fixed period mention in the tender Schedule the work agreement and work order will be automatically cancelled.
