Expression of Interest for selection of organization of Krushi Ratha under the IEC 2023-24, State Plan.

Expression of Interest (Eoi) is invited by the Chief District Agriculture Officer, Mayurbhanj for selection farms/ Agencies for organization of Krushi Ratha under IEC State Plan for Mayurbhanj District. Will be conducted in 26 blocks i.e. Baripada, Shamakhunta, Suliapada, Betnoti, Morada, Rasgobindpur, Badasahi, Udala, Kaptipada, Khunta, G. B. Nagar, Bangripasi, Kuliana, Saraskana, Karanjia, Sukruli, Thakurmunda, Jashipur, Raruan, Rairangpur, Bisoi, Kusumi, Bijatala, Bahalda, Jamda and Tiring awareness each block and should be installed with a loud speaker accompanied by a group of folk dances/ drama actists to spread the message at various place by way of Drama/ Dance /Pala. The RATHA will display important agriculture technology, disseminate important schematic programmes & other intervention implements in the District through folk dance /drama/ Pala with following terms and condition mandatory.


Terms & Condition

1. The farm/ agency must have valid PAN No. and GST Registration certificate with up to date income tax and GST clearance certificate.
2. The agency should not be black listed.
3. The agency should have past experience for similar assignment in Agriculture dept.
4. The vehicle used in the programme must be road worthy and shall not be more than three years old from the date of initial registration with valid RC, insurance certificate, fitness certificate, and other valid documents for plying the vehicle.
5. The driver of the vehicle must have valid driving license.
6. The Ratha should be decorated with sound system.
7. The Ratha should cover all the GPs headquarter and important places for six days.
8. The movement of Ratha will be twice in a year i.e. at the beginning of the Kharif and beginning of the Rabi.
9. The movement of Ratha will be done as per the road chart of the BAOs
10. The agency should take GPS photographs of the event on daily basis.
11. The payment will be released through RTGS to the account of the agency on successful completion of the programme duty certified by Block Agriculture Officer.
12. The authority reserves the right to cancel the EOI at any time without assigning any reason.
