DETAILED TENDER CALL NOTICE No. 01 /Raruan/2025-26

1. The Block Development Officer, Raruan on behalf of Governor of Odisha invites percentage rate bids in sealed cover in conformity with detailed tender call Notice No. 01/2025-26 to be eventually drawn up in state P.W.D. Form P-1 contract for the execution of works detailed in the table below from the intending and eligible Class of Contractors mentioned against the works registered with the State Government and contractor of equivalent Grade/Class registered with Central Government/M.E.S./Railways for execution of Civil works on production of definite proof from the appropriate authority.

2. The Bid document shall be available on <https://mayurbhanj.odisha.gov.in> from Dt. 05.05.2025 till 1:00 PM of Dt. 19.05.2025 and the same can be downloaded.

3. Bids shall be received by the Block Development Officer, Raruan in official time from **Dt. 05.05.2025** and close on **Dt. 19.05.2025** at **1 PM (only on official days and official hours)** through drop box by self or special messenger at Block Office or by registered/speed post only on the address **"To the BDO, Block Development Officer, Raruan"**. The authority will not be held responsible for postal delay in the delivering of the documents or non-receipt of the same.
 4. **The tender will be opened in the Conference Hall of the Block Development Officer, Raruan at 10:00 AM, on 20/05/2025** in presence of the bidders or their authorized representatives who wish to attend. If the office happened to be closed on the date of receipt /opening of the bids as specified, the bids will be received /opened on the next working day at the same time and venue.
 5. If the tender documents sent through registered /Speed Post does not reach the concerned office by the above date and time, the offer will not be considered on any account even if the tender documents were dispatched by the tenderer before the due date.
 6. The following documents should be furnished along with the tender paper failing which the tender is liable for rejection.
 - a. Original Demand Draft of Rs.6000/- in favour of Block Development Officer, Raruan payable at Raruan towards Cost of tender paper (non-refundable)
 - b. EMD duly pledged in favour of the BDO, Raruan.
 - c. Self-Attested copy of the contractor valid registration certificate/ License.
 - d. Self-Attested copy of PAN CARD.
 - e. Self-Attested copy of valid GST registration Certificate.
 - f. Attested copy of caste certificate for SC/ST contractor desirous of availing preference, if applicable
 - g. Self-Attested Copy of PH Certificate for differently-abled Contractors, if Applicable
 - h. Affidavit for Engineer contractor, if any
 - i. Signed copy of DTCN and price bid duly filled in and signed by the tenderer.
 - j. An affidavit regarding authenticity of the credentials.
 - k. No Relationship Certificate in the prescribed Performa.
 7. The tender is to be submitted in one cover along with all document described and documents required as per the relevant clauses of this DTCN and special conditions if any. **The cover is to be sealed and super scribed as the name of the work for bid as mentioned in column No.2 of Box 01 of the tender call notice failing which it will be liable for rejection.**
 8. The bid must be accompanied by EMD of the amount @ 1%(One percent) of the tender cost as mentioned in column No.4 along with tender in shape of deposit Receipt from Scheduled Bank/ National Saving Certificate / Post Office Savings Bank Account/ Post Office Time Deposit Account/ Kissan Vikash Patra in favour of the Block Development Officer, Raruan as per the terms and conditions laid down in OGFR. Tenders not accompanied with EMD as specified above shall be liable for rejection.
 9. **All the tenders where rate quoted is more than 15% less than the scheduled rate will be rejected.**
 10. S.C. /S.T. Tenderers can avail facilities as per Govt. circular.
 11. The bidders shall have to furnish an affidavit along with the bid regarding the authenticity of the bid document
 12. **ADDITIONAL PERFORMANCE SECURITY** shall be obtained from the bidder when the bid amount is less than estimated cost put to tender as per percentage rate quoted. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the Additional Performance Security (APS) as tabulated below.

In shape of Demand Draft in favour of *the Block Development Officer Raruan* before execution of agreement as per Works Deptt. office memo No.4559 dated.05.04.2021, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder as per Works Department Office Memorandum No.14299 dtd.03.10.2017.

13. All bids received will remain valid for period of 30days from the last date of receipt of bids and the validity of the bids can also be extended, if agreed to by the bidders with the department.
14. Other details can be seen in the bidding documents.
15. If the L1 bidder does not turn up for agreement after finalization of tender, then he/she shall be debarred from participation in bidding for three years and action will be taken to blacklist the bidder. In that case L2 bidder if full fill, other required criteria would be called for drawing agreement for execution of work subject to the condition, that L2 bidder negotiate at par with the rate quoted by the L1 bidder otherwise tender will be cancelled.
16. The rates to be quoted by the contractor shall be excluding GST. The implementation of the GST rules by the GOVT of Odisha is to be accepted by the bidder at any point of time.
17. If the rate quoted by the tenderers is found to be same, tender committee will decide the tender.
18. The **Block Development Officer, Raruan** reserves the right to reject any or all the tenders without assigning any reason thereof.




