

Perused the case record bearing De-reservation Case No. 57/2021 containing proposal of Tahasildar, Khunta received from the Sub-Collector, Kaptipada, Udala along with his recommendation seeking sanction of de-reservation of the following land schedule for regularization of land in favour of School & Mass Education Department, Govt. of Odisha Marfat- Govt. Upper Primary School, Jamsul at mouza - Jamsul under Khunta Tahasil.




