- 4. Date of Opening of the tender Paper:** The Bids will open on Dt. 18.06.2025 at 03.00 P.M. at the Conference Hall, Panchayat Samiti, KAPTIPADA, MAYURBHANJ in the presence of the bidders who wish to attend. may be postponed as per the convenience of the authority by intimating all the concerned tenderers through notice affixing to notice board at Office of the Block Development Officer, KAPTIPADA, Mayurbhanj.

5. Additional Performance Security Deposit: Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tenders per works dept. Letter No. 4710 .dt12.04.2022 In such an event, only the successful bidder who has quoted less bid price/rates than the estimate cost put to tender shall have to furnish the exact amount of differential cost i.e., Estimated cost put to tender minus the quoted amount as additional performance security (APS) in shape of N.S.C/K.V.P/Postal time deposit pass book/Term Deposit receipt duly pledged in favour of BDO, KAPTIPADA within 7(seven) days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder.

Below 5%	:	No Additional Performance Security
From 5% & above and below 10%	:	50% of (Difference between estimated cost put to tender and Bid amount.
From 10% and above	:	150% of (Difference between estimated cost put to tender and Bid amount.

6. The following Documents should be furnished with the tender paper failing which the tender is liable for Rejection.
- EMD Pledged in favour of BDO KAPTIPADA.
  - Self Attested copy of valid Contractor Registration Certificate.
  - Self Attested copy of valid Pan Card & GST Certificate.
  - SC/ST Contractors submit original Affidavit in support of cast certificate and attested copy of Cast certificate.
  - Bank Draft towards cost of Tender paper in favour of BDO, KAPTIPADA.
  - P.H. contractor should submit original Affidavit in support of PH certificate regarding EMD Exemption.
  - An Affidavit in support of the authority of documents including no Relation certificate should be attached with Tender Paper.
7. Engineering Contractors desiring to avail the exemption facility of EMD should submit an original affidavit as regards, the fact of availing award of work without submission of EMD/ISD during the current financial year. He should also produce original contract licence at the time of opening of tender document to make necessary entry to that effect as such facilities are limited to three participation in tender during a financial year. Otherwise, their tender will be liable for rejection.
8. The SC/ST Contractors desirous of availing preference should submit an original affidavit in support of caste certificate and attested copy of caste certificate, Otherwise their tender will be liable for rejection S.C. /S.T. Tenderers can avail facilities as per Govt. circular
9. G.S.T. as applicable shall be paid extra over and above the work value. The Contractor shall however be required to submit the TAX INVOICE along with the R.A. / final bill released of the G.S.T. amount by the department.
10. Shortfall of any required documents, Tender paper is liable for rejection.

If the L1 bidder does not turn up for agreement after finalization of tender, then he/she shall be debarred from participation in bidding for three years and action will be taken to blacklist the bidder. In that case L2 bidder if full fill ,other required criteria would be called for drawing agreement for execution of work subject to the condition, that L2 bidder negotiate at par with the rate quoted by the L1 bidder otherwise tender will be cancelled.
13. The reinforcement steels / structural steels shall be of approved brand and specification as per Govt. Circular (Woks Dept.) are used in different field works.

15. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
