Tender Call Notice

Sealed tenders are invited from the eligible bidders as per the eligibility criteria for **Supply of Vaccine Van under ZSS, Mayurbhanj.**

1. This document specifies the technical requirements, commercial terms, and evaluation criteria for the procurement of Vaccine Vans (BS-VI compliant) for use in public health cold chain logistics under the ZSS, Mayurbhanj.

2. Scope of Supply

The bidder shall supply fully functional Vaccine Vans with the following:

- Vehicle chassis-cab as per technical specifications.
- Insulated body suitable for cold chain transport.
- Standard accessories (jack, tools, spare tyre).
- Registration, insurance, and roadworthiness certificates.
- Comprehensive warranty and post-delivery service support.

3. The bidders have to submit their tenders in separate sealed covers (i.e. **Cover “A”- Technical Bid & Cover “B”- Price Bid**). Both the covers should be put into a third **Cover “C”** which must be super-scribed as **“Tender for “supply of Vaccine Van under ZSS, Mayurbhanj”**.

4. The Cover “A” (Technical Bid) should contain as follows: -

- a) Checklist with details of the documents enclosed in **Cover “A”** (as per **Annexure - I**) with page number. The document should be **serially arranged** as per this **Annexure - I** and should be securely tied and bound.
- b) Manufacturing unit / supplier, who has been blacklisted either by the Tender inviting authority or by any state Govt. or Central Govt. organization, is not eligible to participate in the tender for that item during the period of blacklisting. They should submit a declaration about this by a **Notary Public (Annexure – IV)**.
- c) EMD of **Rs.50,000/-** (Rupees Fifty Thousand only - **Refundable**) in shape of Bank Draft / Bankers Cheque in favour of ZSS Non NRHM Funds, Mayurbhanj payable at Baripada.
- d) Tender paper cost of **Rs.2,000/-** (**Rupees Two Thousand only – Non refundable**) in shape of Bank Draft / Bankers Cheque in favour of ZSS Non NRHM Funds, Mayurbhanj payable at Baripada.
- e) The specification of the Vaccine Van is at **Annexure – V**.
- f) List of Item (s) Quoted individually in the prescribed format. (**Annexure – II**).
- g) Copy of organization PAN.
- h) Copy of organization Income Tax Acknowledgement Report (**Assessment Year 2024-25**) and copy of the audited financial statement for the last three financial year i.e. **2021-22, 2022-23 & 2023-24**.

- i) Photocopy of the up-to-date GST Registration certificate & GST filling report for the month of June 2025, July 2025 & August 2025.
- j) Copy of Valid Manufacturing License of the manufacturer (s) / Import License by the Importer (also to be submitted by the authorized distributor).
- k) Copy of valid ISO Certificate.
- l) All the tender documents should sign by the bidders at the bottom of each page with his official seal duly affixed.
- m) Leaflet / Technical Brochures of the products / item offered.
- n) They should quote the rates inclusive of insurance, packing, forwarding, freight (door delivery) and GST (if any) and should submit a self declaration about this.
- o) They must submit the undertaking that they will supply the stocks **within 45 days** after receipt of the Purchase Order from this office.
- p) The supplier shall have a minimum average turnover of Rs. 01 Crore or more in the last three-year financial years i.e. 2021-22, 2022-23 & 2023-24 and copy of the audited financial statement for the last three financial year i.e. 2021-22, 2022-23 & 2023-24.

5. Warranty & After-Sales Support

The supplier shall provide a minimum warranty of 3 years on the vehicle engine and insulated body. During the warranty period, all manufacturing defects shall be rectified free of cost. The supplier shall maintain a service network for maintenance and supply of spare parts within the State.

6. General Condition:

- a) Eligible bidders should submit their tender documents to the CDM & PHO Mayurbhanj through **Speed Post / Registered Post/Courier** with in the stipulated date & time as mentioned in the tender notice.
- b) Any tender documents received after the due date & time will be rejected and returned to the sender unopened.
- c) A Pre-bid meeting will be held on the stipulated date & time in the O/o. CDM & PHO Mayurbhanj.
- d) Violating the tender terms and conditions & non-supply / partially supply / supply, which is not as per technical specification, will be declared as **Blacklisted** and disqualify the firm to participate in any tender of this district for a period of next 03 (three) years from the date of issue of the letter and their E.M.D. will be forfeited.
- e) Tender documents should be typewritten or computerized, failing which the bidders will be ineligible for consideration. No further correction will be allowed.

- b) The rates should be computerized.
- c) If there is difference between figures & words, words will be taken into consideration.

- Transmission: 5-speed synchromesh manual gearbox
