The procedure of bid submission using electronic payment of Tender Paper Cost and Bid Security Declaration Form by the bidder may be referred in Works Deptt. O.M. No. 17254, dt. 05.12.2017. The cost of tender paper is non-refundable.
- 4 The Bid documents will be available in the website www.tendersodisha.gov.in, from **2.00 PM of 12.11.2025 to 5.30 PM of 26.11.2025** for online bidding.
- 5 The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class II or Class III.

- 7 Bid received "online" will be opened at **11.00 A.M. onwards from 27.11.2025** in the office of the Project Administrator, ITDA, Rairangpur as per availability of internet. Bidders who participated in the bid can witness the opening of bids after login on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of bids as specified, the bids will open on the next working day onwards at the same time and venue.
- 8 Engineer Contractor who wants to avail EMD Exemption shall have to furnish scan copy of affidavit along with tender, declaring there through affidavit in that he/she has not yet availed three numbers of EMD Exemption during this financial year and to show the original registration certificate to the tender opening authority for verification without which the tender will be rejected. SC/ST contractors desires of availing benefit as per Works Department Resolution No. 27748, dt. 11.10.1977 must submit work specific affidavit for the same along with attested copy of Caste Certificate.
To avail 50 % exemption of EMD and 10 % price preference : The intending SC/ST tenderer(s) up to B Class should upload the scan of the caste certificate along with affidavit for exemption of 50 % EMD and also the copy of application for availing 10 % price preference otherwise the tenderer will be treated as General category.
Physical Handicapped (P.H.) Category "D" & "C" class contractor who wants to avail EMD/ISD exemption shall have to furnish scan copy of affidavit along with attested copy of disability certificate (Refer Work Deptt., Odisha, Bhubaneswar Resolution No. 23934/Dt. 08.11.1991) along with tender.
- 9 No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the state Government is allowed to work as Contractor for period of two years after his retirement from Government service without Government permission.
- 10 Amendment to Appendix-IX, Clause-36 of OPWD Code Vol.-II by inclusion. If the rate quoted by the bidder is exactly 15 % less or more than 15 % less of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99 % (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidders/ their authorized representatives & PA, ITDA will remain present.
- 11 "Additional performance security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost as per Works Department Office Memorandum No. 4559/Dt. 05.04.2021 in shape of Demand Draft / Term Deposit Receipt Pledged in favour of the Project Administrator, ITDA, Rairangpur within seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiating against bidder".
- 12 The bid must be accompanied with checklist (online) as prescribed in the DTCN and submitted with original documents for necessary verification during scrutiny of documents after opening of the bids.
- 13 All the tenderers are required to submit a list of works which are in hand at the time of submitting their tenders, as per OPWD Code Vol-II, Appendix-IX i.e. i) Name of work, ii) Name & particulars of the Division/Office where the works are being executed, iii) Amount of work, iv) Position of work (a) Completed (b) in progress & v) Remarks.

- 14 Only those bidders who successfully remit their tender paper cost and EMD/ EMD exemption affidavit declaration as the amount specified against the work electronically as per Works Department Memo No. 17254 Dt. 05.12.2017 would be eligible to participate in the tender or bid process. Pending or failure payment status shall not be able to submit their bid to Tender Inviting Authority(TIA), State Procurement Cell, the designated Banks shall not be held responsible for such failure. For that bidders are advised to submit their bids well in advance within stipulated period.
- 15 DTCN signed, Affidavit of Authenticity of documents, valid GSTIN Registration Certificate, PAN Card, valid contractors Registration Certificate and other documents as mentioned in the DTCN must be stand in pdf format in the website along with the bid. All the signatures in relevent documents must be tallied with valid contractor registration certificate, otherwise the bid documents shall not be taken into consideration.
- 16 **The amount put to tender is exclusive GST. GST as applicable on works contract shall be paid over the bill amount at the time of payment of bill.**
- 17 **All the works are time bound and critical in nature, no extension of time will be allowed. If the work will not completed in the assigned schedule time with valid reason, the work order is deemed to be cancelled without giving any reason thereof. No further communication will be made.**
- 18 **Any change in Royalty and GST rate shall be applied in billing procedure which will be binding on the contractor and no extra claim will be entertained.**
- 19 The bidders those who are failure / defaulter to complete the works with specified approved time in this ITDA their bids are summarily treated as rejected.
- 20 Any doubt or clarification if arises, over the terms & conditions and specification of the work may be requested through online only (e-tender portal) as per provision of the e-tender OPWD Code.
- 21 The bidders shall provide their E-mail-ID, mobile no.(whatsapp) and correspondance address positively. Any official communication to be provided through E-mail-ID and whatsapp mobile no. will be treated as proper and authentic.
- 22 Any addendum/corrigendum/cancellation of above tender will be published in the website www.tendersodisha.gov.in and in the notice board.
- 23 In case of equal rates quoted by all the bidders at zero (0.00) % excess or less i.e. schedule of rate over the estimated cost put to tender shall be rejected and fresh tender will be invited.
- 24 **The undersigned reserves right to reject the bidders if any documents found incorrect/false at any stage of bidding.**
- 25 **The undersigned reserves right to cancel / modify any or all bids without assigning any reason thereof.**
