

Perused the case record bearing De-reservation Case No. 27/2025 submitted by Tahasildar Bijatala vide letter No.2947 Dated 20.12.2025 for change suit land from "Abad Ajogya Anabadi" (AAA) Khata to "Abad Jogya Anabadi"(AJA) and Kisam from Patharbani to Patit in respect of the following scheduled of Govt. Land towards alienation in favour of Co-operation Department Govt. of Odisha for Construction of Large Area Multipurpose Co-operative Society (LAMPCS) Bijatala in mouza -Damudibeda under Bijatala Tahasil.

The Requisitioning Officer, i.e., the Deputy Registrar, Cooperative Societies, Mayurbhanj, Baripada, being duly authorized by the Registrar, Cooperative Societies, Odisha, has submitted Form-1A after affixing the requisite court fees.

The proposed Govt. land as mentioned above identified by the Tahasildar Bijatala has been approved in the Sub-Divisional Site Selection Committee Meeting held on 10.11.2025. The copy of the proceeding is attached with the case record.

It is observed that the proposed plots stands recorded under "Abad Ajogya Anabadi" Khata with kisam-Patharbani. Thus, it is required to be brought from "Abad Ajogya Anabadi" Khata to "Abad Jogya Anabadi" Khata and Kisam from Patharbani to Patit through the De-reservation preceding as per Para-10(4) of letter No 4898 dated 28.01.1966 of Revenue and Excise department for eventual alienation.

It is seen that General Proclamation inviting public objection, if any, against the proposed De-reservation has been duly published on 04.12.2025, as required under Rule-4(1)(i) in the manner prescribed in Sub-Rule 5(5) of the O.G.L.S., Rule. 1983 & OGLS Amendment Rules, 2023 & also published in the Mayurbhanj District Website and reportedly no objections has been received from any quarter within the stipulated period as mentioned in Rule 5(6) of the O.G.L.S., Rule. 1983 OGLS Amendment Rules, 2023 against the proposed De-reservation. The copy of the proclamation and screen shot of the publication in the District NIC are enclosed herewith the case record.

As reported, the land is free from encroachment, contains no minor or major minerals, is not included in the DLC list, and is unobjectionable in nature, making it suitable for lease. The proposed land is well connected by road and is appropriate for alienation.

The proposed alienation of land has been approved by the Gram Sabha under the PESA Act, 1996. The BDO, Bijatala has submitted the Gram Sabha proceedings, wherein the proposal was duly approved. A copy of the proceedings has been enclosed, as submitted by the BDO, Bijatala vide Letter No. 3329 dated 01.12.2025
