The Project Administrator, ITDA, Baripada on behalf of the Governor of Odisha invites Percentage Rate bids in Online Mode Double Cover System for the works as detailed in the table, from the class of eligible contractors as mentioned in Column-6 (Six) registered with the State Governments and Contractors of equivalent Grade / Class Registered with Central Government / MES / Railways to be eventually drawn up in P-1 form / other available forms for execution of the civil works, o production of definite proof from the appropriate authority. But successful bidder other than State/MES/Railways/CPWD in equivalent rank has to register under the State PWD before signing the agreement. The proof of registration from the appropriate authority shall be enclosed along with the Bid.
2. The bidders may submit bids for any or all of the following works as per their eligibility.

5. The cost of Tender Paper and EMD as indicated above shall be received online along with the bids as per guideline issued by Works Deptt. O.M. No. 6785, dt. 09.05.2017 and No. 17254, dt. 05.12.2017 & No. 5984/W, dt. 27.04.2021. The procedure of bid submission using electronic payment of Tender Paper Cost and EMD by the bidder may be referred in Works Deptt. O.M. No. 17254, dt. 05.12.2017 & No. 5984/W, dt. 27.04.2021, which has been added to the DTCN.
6. The Bid documents will be available in the website <https://tendersodisha.gov.in> from 10.00 AM of 27.01.2026 to 05.30 PM of 16.02.2026 for online bidding.
7. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class II or Class III.

9. Bids received "On-line" will be opened at 11.00 AM onwards from 17.02.2026 in the office of the PA, ITDA, Baripada as per availability of internet. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day onwards at the same time and venue.
10. Engineer Contractor who wants to avail EMD Exemption shall have to furnish scan copy of affidavit along with tender, declaring there in that he/she has not yet availed three numbers of EMD Exemption during this financial year and to show the original registration certificate to the tender opening authority for verification without which the tender will be rejected. SC / ST contractors desires of availing benefit as per Works Department Resolution No. 27748, dt. 11.10.1977 must submit work specific affidavit for the same along with attested copy of Caste Certificate.
11. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the state Government is allowed to work as a Contractor for a period of two years after his retirement from Government service without Government permission.
12. Scanned clear copies should be uploaded. Invisible copies of Documents may be liable for rejection.

13. The amendments made vide works Dept. Memorandum No. 12366 Dtd 08.11.13, No- 10224 Dt. 01.09.2015 and Lr. No:-20415 Dt 14.09.2015 towards general instruction to the contractor except para 3.5.5 (v) Note II of OPWD code, Vol-I will be followed scrupulously regarding rate to be quoted etc.
14. In pursuance to the Govt. of Odisha Works Deptt. Office Memorandum No. 173 dt. 03.01.2026 Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have furnish the APS in the rates as noted below.

15. As per O.M No 1499 dated 01.02.2023 of works Department, Government of Odisha "Security for the due fulfillment of a contract should invariably be taken. The security may be taken in shape of N.S.C./ Post Office Savings Bank Account/ Post Office Time Deposit Account/ Kisan Vikas Patra./ Bank Guarantee in favour of the Divisional Officer from any Nationalized Scheduled Bank in India counter guaranteed by its local Branch at Bhubaneswar/ e-Bank Guarantee executed on the National e-Governance Services Limited (NeSL) Digital Document Execution Portal towards E.M.D/initial Security Deposit/ any other security deposit from the contractor or supplier." And the same may be pledged in favour of the Superintending Engineer, M.I Division, Jashipur within 7 (Seven) days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for black listing shall be initiated against the bidder.
16. As per O.M. no. 632 dtd. 09.01.2026 if more than one bid will be 1<sup>st</sup> lowest the tender and quoted either at the estimated cost put to tender or less than the estimated cost put to tender will be finalized through a transparent lottery system in presence of the bidders or their authorized representative.
17. The Contractors who have more than three works pending under this Division and who has not completed the work in time and contract has been closed or recommended for closer with penalty under this Division at the time of bidding are not eligible to participate in the present tender.
18. "Additional performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost as per Works Deptt. Office Memorandum No.4559 Date. 05.04.2021 in shape of Demand Draft / Term Deposit Receipt Pledged in favour of the **Project Administrator, ITDA, Baripada** within seven days of receiving intimation to deposit, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder".
19. **Only those bidders who successfully remit their Cost of Tender Paper and EMD would be eligible to participate in the tender/bid process.** The bidders with pending or failure payment status shall not be able to submit their bid. Tender inviting authority, State Procurement Cell, NIC, the designated Banks shall not be held responsible for such pendency or failure.
20. The bid must have accompanied with Check List (Online) as prescribed in the DTCN & submitted with original documents for necessary verification during scrutiny of documents.

21. The original documents of the bidders may be required for physical verification by the authority on intimation after opening of bids.
22. Authority will not be held responsible for system failure, malfunction of internet or traffic jam. Bidders are advised to submit their bids well in advance within the stipulated period.
23. The amount put to tender is exclusive of GST. The intending Bidders should offer their rates which shall be exclusive of GST applicable as per norms. GST as applicable on works contract shall be paid over the bill amount at the time of payment of Bill.
24. DTCN signed, Affidavit of Authenticity of documents, GSTIN Registration Certificate, PAN Card, valid Contractors Registration Certificate & other documents as mentioned in the DTCN must be Scanned and uploaded in pdf format in the web-site along with the bid. All the signatures in relevant documents must be tallied with valid Contractor Registration Certificate, otherwise the bid documents shall not be taken into consideration.
25. Any type of conditional tenders will not be accepted and liable for rejection. When the tender has been selected for acceptance and the required amount of the security money has been deposited, the Project Administrator, ITDA shall scrutinize all pages of the form of Item, Rate, percentage, excess or less tender and Contract for works to see that the form has been properly filled up and signed by the contractor and the signature witnessed.
26. Any doubt or clarification if arises, over the terms and conditions and specification of the work may be requested through online only (e-tender portal) as per provision of the e-tender in OPWD Code.
27. Any change in royalty and GST rate shall be applied in billing procedure which will be binding on the contractor and no extra claim will be entertained.
28. The bidder shall provide their valid e-mail ID, mobile Number, and correspondence address. Any official communication to be provided through E-mail ID will be treated as proper and authentic.
29. Other details can be seen in the bid documents and any conditions related to this tender will be followed as per the OPWD codal procedure.
30. Any addendum / corrigendum / cancellation of above tender will be published in the web-site <https://tendersodisha.gov.in> and in the notice board.
