Sealed tenders are invited from the eligible bidders as per the eligibility criteria for **"Supply of Essential equipment/instruments under Bio-Medical Waste Management (BMWM)"** for different Health institution of Mayurbhanj district.

1. The bidders have to submit their tenders in separate sealed covers (i.e. **Cover "A"- Technical Bid & Cover "B"- Price Bid**). Both the covers should be put into a third **Cover "C"** which must be super-scribed as **"Tender for "Supply of Essential equipment/instruments under Bio Medical Waste Management (BMWM)" and Tender Reference No. _____**.
2. **The Cover "A" (Technical Bid) should contain as follows:**
 - 1) Checklist with details of the documents enclosed in **Cover "A"** (as per **Annexure - I**) with page number. The document should be *serially arranged* as per this **Annexure - I** and should be securely tied and bound.
 - 2) Manufacturing unit / supplier, who has been blacklisted either by the Tender inviting authority or by any state Govt. or Central Govt. organization, is not eligible to participate in the tender for that item during the period of blacklisting. They should submit a declaration about this by a **Notary Public**.
 - 3) EMD **Rs.2,00,000/- (Rupees Two Lakh only - Refundable)** in shape of Bank Draft / Bankers Cheque in favor of ZSS Non NRHM Fund, Mayurbhanj payable at Baripada.
 - 4) Tender Paper Cost **Rs.5,000/- (Rupees Five Thousand only – Non-refundable)** in shape of Bank Draft / Bankers Cheque in favor of ZSS Non NRHM Fund, Mayurbhanj payable at Baripada.

 - 11) Leaflet / Technical Brochures of the products / item offered.

- 12) They should quote the rates for individual items inclusive of insurance, packing, forwarding, freight (door delivery) and exclusive GST (if any) and should submit a self-declaration about this. A written undertaking bidder/OEM Letter head with Witness is to be submitted along with the bid document to that effect.
- 13) They must submit the undertaking that they will supply the stocks **within thirty days** after receipt of the Purchase Order from this office. 4. **The Cover "B" (Price Bid) should contain as follows:**

 - 2) The rates should be computerized.
 - 3) The price quoted by the tenderers shall not in any case, exceed the controlled price, if any, fixed by the Central / State Government and the Maximum Retail Price (MRP). The purchaser, at his discretion, will in such case, exercise the right of revising the price at any stage so as to confirm to the controlled price or MRP as the case may be deleted.
