


Terms & Conditions:-

1. After field survey and investigation, Model Plan (minium two numbers) for each Building need to be prepared as per direction of the Engineer-in Charge and the same in hard copies to be submitted for check & selection. The approved list of projects will be available in ITDA, Kaptipada.
2. Basing on the selected plan for each Building, further plan, selection, structural designs and working drawings are to be prepared and submitted with detailed estimates along with, rate analysis for different location will be provided by the ITDA, Kaptipada.
3. Four sets DPR and drawing both in hard and soft copy duly technically sanctioned are to be submitted to ITDA, Kaptipada.
4. The survey and investigation, soil testing with report of projects should be done by the firm at their own cost.
5. The Agency must prepare and supply more numbers of drawings if required at any stage.
6. All drawing are to be printed on A3 to A4 size papers for clear visibility of specifications.
7. All estimates are to be printed on A4 size paper only with proper binding.
8. The Agency must be ready to undertake any number of addition and alternations of drawing and estimate if required.
9. The GST as applicable will be paid as per Govt, norms.
10. The GST of the firm should be submitted update till last financial quarter and GST Bills are to be submitted in duplicate for necessary payment.
11. The payment will be released after successful bidding.
