



The Requisitioning Officer, i.e., the Chief Dist. Medical & Public Health Officer, Mayurbhanj, Baripada, being duly authorized by Deputy Secretary to Government Health & Family Welfare Department, Govt. of Odisha has submitted Form-1A after affixing the requisite court fees.


