



It is required to be brought from "Rakhit" Khata to "Abad Jogya Anabadi" Khata and from "Gochar" Kisam to "Patit" Kisam respectively through the de-reservation proceeding advanced by the Tahasildar, Rairangpur, as per provision under section 3(A) of the O.G.L.S Act-1962.</p> <p>It is seen that General Proclamation inviting public objection, if any, against the proposed de-reservation has been duly published, as required under Rule-4(1)(i) in the manner prescribed in Rule 5(5) of the O.G.L.S., Rule, 1983 and reportedly no objection has been received from any quarter within the stipulated period as mentioned in Rule 5(6) of the O.G.L.S., Rule, 1983 against the proposed de-reservation.</p> <p>As reported in the Field visit memorandum, the proposed site is free from encroachment and there is neither any forest growth nor any sairat sources existing on the suit land.</p> <p>As reported by the Asst. Settlement Officer (HdQRS.), Baripada, the sabik kisam of the proposed plot is "GOCHAR" and it is also not enlisted in the District Level Committee report which formed the basis for the affidavit filed by State Government before the Hon'ble Supreme Court of India in WP (C) No. 202 of 1995 (T.N. Godavarman Thirumulkpad Vs Union of India and others).</p> <p>The proposed land is coming under urban area of Rairangpur Municipality and kept reserved in "Category- III as per Revenue Master Plan of Rairangpur Municipality area which is approved by the R.D.C. (C.D.), Cuttack.</p> <p>The quantum of excess Gochar land in the village is not required, as the proposed land is coming under Urban area, as per the provision U/R 4(2) in OGLS Rules, 1983.</p> <p>All required formalities have been maintained by the Tahasildar, Rairangpur in this case record, for de-reservation of proposed plot.</p> <p>The purpose of de-reservation is for public purpose.</p> <p>Hence, the De-reservation proposal advanced by the Tahasildar, Rairangpur and recommended by the Sub-Collector, Bamanghaty, Rairangpur is hereby approved, as provided U/S 3(A) of the O.G.L.S. 
