1. The sealed quotations shall be received by the undersigned through the Registered Post or by hand on **working days** at the Office Chamber of the Child Development Project Officer, Jamda from **Dt.25.03.2026 to Dt.03.04.2026** by **5pm**.
2. No quotation will be entertained after the stipulated date and time.
3. Any Firm black listed by Central/State Government/ Board/ Corporation/ Autonomous body under Administrative control of Central/State Government etc. will not be entertained by the Tender Committee.
4. The Quotationers have to submit the following documents given below without which the Quotation shall be rejected;
 - A. Self attested GST Registration Certificate of the Registered Firms/ Co-operative Societies/ Agencies.
 - B. Self attested PAN card.
 - C. Self attested Income Tax Return Acknowledgement of assessment year 2025-26.
 - D. Self attested 1st page of the bank statement copy of the respective Firms/ Co-operative Societies/Agencies.

5. The quotationers are to be present with the sample items (Sand bucket, Water bucket and fire blanket) during opening of quotation to be examined and finalized by the committee.
6. The quotation once submitted cannot be exchanged.
7. The successful bidder should complete the supply of **Fire safety equipments (Sand bucket, Water bucket and fire blanket)** within 7 days from the receive date of supply order copy & also the payment will be made after the verification of complete supply of aforesaid items.
8. The maximum rate per one set of **Fire safety equipments containing one Sand bucket, one Water bucket and one fire blanket (Minimum size-6feet x 4feet)** should be **Rs.1,000/- (inclusive of all taxes)**.
9. The Lowest Quoted firm without compromising the quality will be considered for the above Quotation. Committee may accept the higher rate quoted by any quotationer considering the quality of the articles.
10. The rate quoted by the quotationers should be inclusive of all taxes including transporting charges and delivery of the materials to the respective AWCs under ICDS Project, Jamda.
