TENDER CALL NOTICE No. 03/2025-26

The Block Development Officer, Badasahi on behalf of Governor of Odisha invites percentage rate bids in sealed cover in conformity with detail tender call Notice No.03/2025-26 to be eventually drawn up in state P.W.D. Form P-1 contract for the execution of works detailed in the table below from the intending and eligible Class of Contractors mentioned against the work registered with the State Government and contractor of equivalent Grade/Class registered with Central Government/M.E.S./Railways for execution of Civil works on production of definite proof from the appropriate authority.

Terms & Condition

1. The Bid document can be obtained from the Block Development Officer, Badasahi on payment of cost of the tender paper (non refundable) in shape of Cash.
2. The tender paper will be sold from date **25/03/2026 to 06/04/2026** on working days only from **10:30 AM to 05:00 PM** in the Office of the Panchayat Samiti, Badasahi.
3. Bids shall be received by the Block Development Officer, Badasahi in official time from **Dt. 25/03/2026 and close on Dt. 06/04/2026 at 5:00 PM (only on official days and official hours)** through **drop box by self or special messenger at Block Office or by registered/speed post only on the address "To the BDO, Block Development Officer, Badasahi"**. The sealed envelope shall be superscripted as "NAME OF PROJECT & SL NO OF THE PROJECT ALONG WITH BID COVER". Separate Envelop for Separate Project should be submitted. The authority will not be held responsible for postal delay in the delivering of the documents or non-receipt of the same.
4. **The tender will be opened in the Conference Hall of the Block Development Officer, Badasahi at 11 AM, on 08/04/2026** in presence of the bidders or their authorized representatives who wish to attend. If the office happened to be closed on the date of receipt /opening of the bids as specified, the bids will be received /opened on the next working day at the same time and venue.
5. If the tender documents sent through registered /Speed Post does not reach the concerned office by the above date and time, the offer will not be considered on any account even if the tender documents were dispatched by the tenderer before the due date.
- 6 The following documents should be furnished along with the tender paper failing which the tender is liable for rejection.
 - a. EMD duly pledged in favour of the BDO, Badasahi.
 - b. Self-Attested copy of the contractor valid registration certificate/ License.

- c. Self-Attested copy of PAN CARD.
 - d. Self-Attested copy of valid GST registration Certificate.
 - e. Attested copy of caste certificate for SC/ST contractor desirous of availing preference, if applicable
 - f. Self-Attested Copy of PH Certificate for differently-abled Contractors, if Applicable
 - g. Affidavit for Engineer contractor, if any
 - h. Signed copy of DTCN, Money receipt of DTCN and price bid duly filled in and signed by the tenderer.
 - i. An affidavit regarding authenticity of the credentials.
 - j. No Relationship Certificate in the prescribed Performa.
7. The tender is to be submitted in one cover along with all document described and documents required as per the relevant clauses of this DTCN and special conditions if any. **The cover is to be sealed and super scribed as the name of the work for bid as mentioned in column No.2 of Box 01 of the tender call notice failing which it will be liable for rejection.**
 8. The bid must be accompanied by EMD of the amount @ 1%(One percent) of the tender cost as mentioned in column No.4 along with tender in the form of DD duly pledged in favor of the Block Development Officer, Badasahi as per the terms and conditions laid down in OGFR and in no other form. Tenders not accompanied with EMD as specified above shall be liable for rejection.
 9. S.C. /S.T. Tenderers can avail facilities as per Govt. circular.
 10. The bidders shall have to furnish an affidavit along with the bid regarding the authenticity of the bid document
 11. **ADDITIONAL PERFORMANCE SECURITY** shall be obtained from the bidder when the bid amount is less than estimated cost put to tender as per percentage rate quoted. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the Additional Performance Security (APS) as tabulated below.

In shape of Demand Draft in favour of *the Block Development Officer Badasahi* before execution of agreement as per Works Deptt. office memo No.4559 dated.05.04.2021, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder as per Works Department Office Memorandum No.14299 dtd.03.10.2017.

12. Other details can be seen in the bidding documents.
13. If the L1 bidder does not turn up for agreement after finalization of tender, then he/she shall be debarred from participation in bidding for three years and action will be taken to blacklist the bidder. In that case L2 bidder if full fill, other required criteria would be called for drawing agreement for execution of work subject to the condition, that L2 bidder negotiate at par with the rate quoted by the L1 bidder otherwise tender will be cancelled.
14. The rates to be quoted by the contractor shall be excluding GST. The implementation of the GST rules by the GOVT of Odisha is to be accepted by the bidder at any point of time.

15. If the rate quoted by the tenderers is found to be same, tender committee will decide the tender.

16. The **Block Development Officer, Badasahi** reserves the right to reject any or all the tenders without assigning any reason thereof.
