Regarding Submission of Past Performance Certificate (Point No. 6, Sub-point (k): As per Point No. 6, Sub-point (k) of the Terms and Conditions, the bidder must have an average annual turnover of not less than Rs. 35.00 lakh for the last three financial years, i.e., 2022-23, 2023-24, and 2024-25. However, the agency has submitted turnover details for the financial years 2021-22, 2022-23, and 2023-24, as follows: a) FY 2021-22 - Rs.21,89,285.00 b) FY 2022-23- Rs.24,89,316.00 c) FY 2023-24- Rs.45,94,137.00 Thus, the required financial years (including 2024-25) have not been fully submitted, and the eligibility criteria regarding average annual turnover has not been fulfilled.</p> <p>2. Regarding Signature Requirement (Point No. 23 of Terms and Conditions): As per the Ponit no.23 of Terms of condition the bidders should have all documents and pages shall be computerized, serially numbered and duly full signature and sealed by the bidder. However, the agency has provided only short signatures on all pages of the bid instead of full signatures, which is not in compliance with the stated requirement.</p>	Disqualified

Regarding Signature Requirement (Point No.23 of Terms and Conditions): As per Point No. 23 of the Terms and Conditions, all documents and pages of the bid must be computerized, serially numbered, and duly signed in full with seal by the bidder. However, it has been observed that the agency has affixed only short/initial signatures on all pages instead of full signatures. Additionally,</p>	Disqualified

		<p>the pages have not been serially numbered. This is not in compliance with the stipulated requirements.</p> <p>2. Regarding Submission of Past Performance Certificate (Point No. 6, Sub-point(k): As per Point No. 6(k) of the Terms and Conditions, the bidder is required to submit past performance certificates as per Annexure-II for the financial years 2022-23, 2023-24, and 2024-25. However, the agency has submitted proof of supply only for the financial years 2022-23 and 2023-24 and has not submitted the required documents for the financial year 2024-25. This constitutes non-compliance with the specified requirement.</p> <p>3. Incomplete Checklist Submission: The agency has submitted an incomplete checklist, which does not meet the prescribed requirements.</p>
