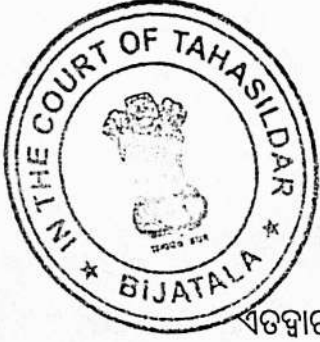

As reported in the Field visit memorandum of Tahasildar, the proposed site is free from encroachment and there is neither any forest growth nor any minor mineral sources existing on the suit land. The suit land has not given advance possession.

As reported by the Asst. Settlement Officer (Hqrs.), Baripada, the sabik kism of the proposed plots is Patharbani.

As reported, the proposal was also sent to BDO, Bijatala to place in Grama Sabha. The copy of the Grama Sabha resolution is attached with the case record.

Tahasildar has also certified that, the proposed land is not found in the DLC list.

All required formalities have been maintained by the Tahasildar, Bijatala in this case record, for change of khata & kism of proposed plot.
