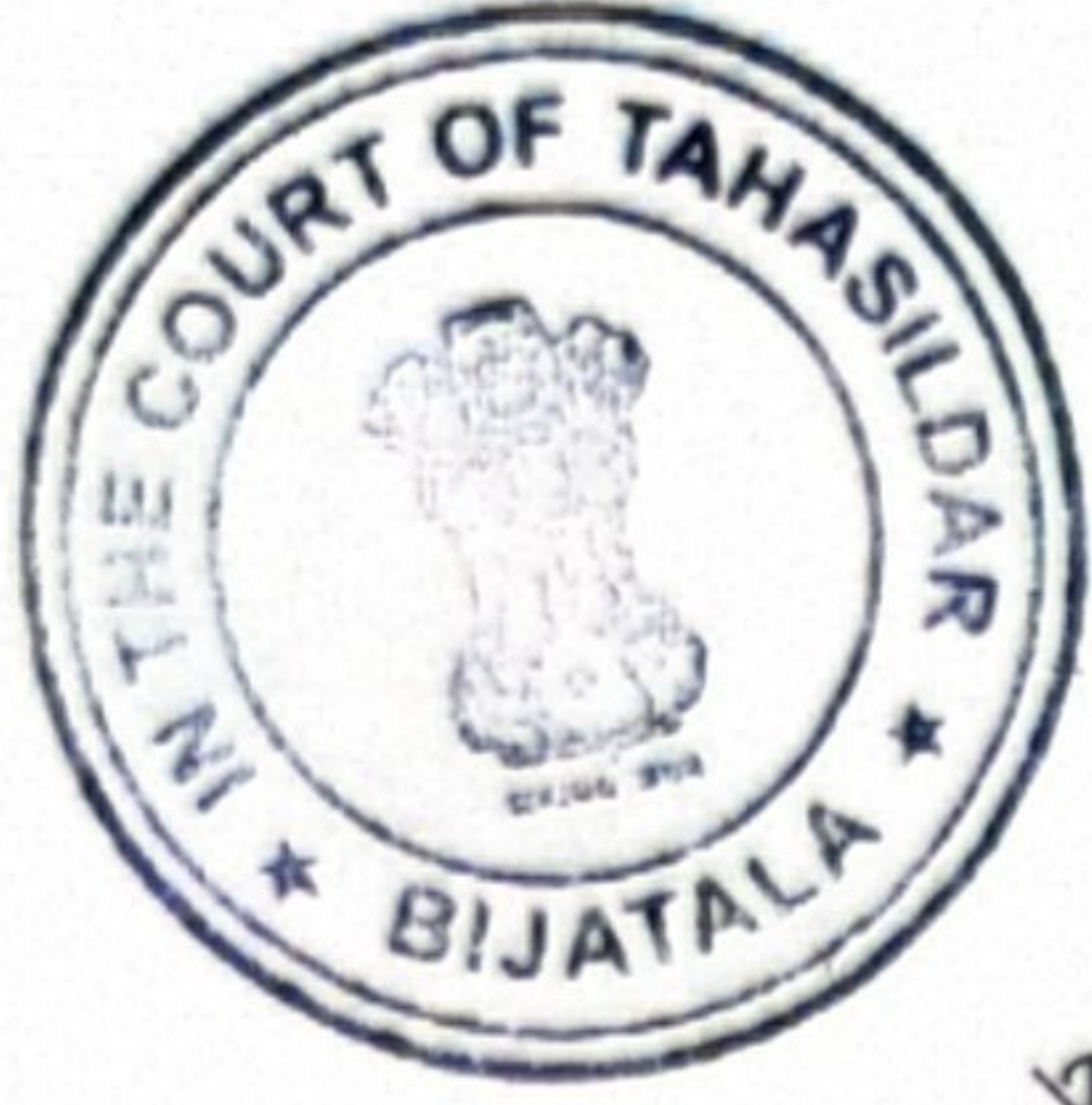

It is required to be brought from "Rakhit" Khata to "Abad Jogya Anabadi" Khata and from "Gochar" Kisam to "Patit" Kisam respectively through the De-reservation proceeding advanced by the Tahasildar, Bijatala, as per provision under section 3(A) of the O.G.L.S Act-1962.</p> <p>It is seen that General Proclamation inviting public objection, if any, against the proposed de-reservation has been duly published, as required under Rule-4(1)(i) in the manner prescribed in Rule 5(5) of the O.G.L.S., Rule, 1983 and reportedly no objection has been received from any quarter within the stipulated period as mentioned in Rule 5(6) of the O.G.L.S., Rule, 1983 against the proposed de-reservation</p> <p>As reported in the Field visit memorandum of Tahasildar, the proposed site is free from encroachment and there is neither any forest growth nor any salt sources existing on the suit land.</p> <p>As reported by the Asst. Settlement Officer (Hdqs.), Baripada, the sabik kisam of the proposed plots are "Gochar" and these are also not enlisted in the District Level Committee report which formed the basis for the affidavit filed by State Government before the Hon'ble Supreme Court of India in WP (C) No, 202 of 1995 (T.N. Godavarman Thirumulpad Vs Union of India and others).</p> <p>Calculation sheet working out of the quantum of excess Gochar land in the village- Nusadihi is prepared by the Revenue Inspector, Khanta and countersigned by the Tahasildar, Bijatala is attached with the case record. Act-1962 and Rule-4(1) of the O.G.L.S.
