#### **NATIONAL COMPETITIVE BIDDING THROUGH e-Tendering**

The **OFFICE OF THE PANCHAYAT SAMITI, kuliana, Odisha** on behalf of Governor of Odisha invites **percentage Rate Bids** through **e-Tendering** in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) in **Single Bid** system from Class of Contractors as mentioned in Col.6 of table registered with the State Governments and contractors of equivalent Grade/Class registered with Central Government/MES/Railways for execution of Civil Works requirements given in the DTCN on **percentage Rate Bids** to be eventually drawn up in the standard **P1 Contract Form**. The bid should be submitted on-line in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) by eligible class of contractors. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). The registered bidders of outside Odisha can also participate in this process, after necessary Portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Government before signing agreement.

1. Mode of Submission of tender: Tender should be submitted online in [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in)

3. a) The bidder should be made payment through online receipt towards Tender Paper Cost. No offline receipt of Tender Paper Cost will be allowed in e-Tendering portal of Government of Odisha.  
b) The bidder should be made payment through online receipt towards EMD. No offline receipt of EMD will be allowed in e-Tendering portal of Government of Odisha.  
c) The scanned copy of Bid Security Declaration, Registration certificate, GST, PAN, EPF or undertaking for EPF & affidavit including all required papers uploaded through website should be produced in original to the **BLOCK DEVELOPMENT OFFICER, KULIANA BLOCK** for verification within six days of opening of Bid, otherwise the tender will be rejected.
