1. The Tender Paper can be obtained from the Block Development Officer, Samakhunta on payment of Cost. of the tender paper (nonrefundable) in shape of cash.

2. Earnest Money Deposit: The bid must be accompanied with E.M.D amount as specified against the work in shape NSC/POID/KVP/POSB/Deposit receipt of the scheduled commercial bank duly pledged in favour of BDO SAMAKHUNTA.

3. Sale and Receipt of Tender Paper: The sale of the Bid documents will be made from the date of publication i.e. from 16.06.2026 to 25.06.2026 from 11AM to 5PM (on working days only) . The sealed Tender Paper will be received working days from 16.06.2026 to 25.06.2026 till 5PM. The same should be submitted either through registered/ speed post addressing to the BDO, Samakhunta or same may be dropped in the tender box kept in the Block office, Samakhunta during working hour. The sealed envelope shall be super scribed as "Tender Paper". (Name of the Project & Sl. No.) undersigned will not be held responsible for any delay in the postal service.

4. Date of Opening of the tender Paper:- The Bids will open on Dt. 29.06.2026 at 11.30.A.M. at the, Conference Hall, Panchayat Samiti, SAMAKHUNTA, MAYURBHANJ in the presence of the bidders or their authorized agents having authorization letter and Block tender committee. If the office happens to be closed (holiday) on the date of receipt/opening of the bids as specified, the bids will be received/opened on the next working day at the same time and venue without further notice. However, date of tender paper opening may be postponed as per the convenience of the authority by intimating all the concerned tenderers through notice affixing to notice board at Office of the Block Development Officer, SAMAKHUNTA, Mayurbhanj.

5. Additional Performance Security Deposit:- Additional Performance Security shall be obtained from the bidder when the bid amount is less than the tender cost put to tenders as per the works deptt. Letter No. 4710 .dt 12.04.2022. In such an event, only the successful bidder who has quoted less bid price/rates than the tender cost put to tender shall have to furnish the amount of differential cost i.e., tender cost put to tender minus the quoted amount as additional performance security (APS) as mentioned below in shape of N.S.C./K.V.P/Postal time deposit pass book/Term Deposit receipt duly pledged in favour of BDO, SAMAKHUNTA within three days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for black listing shall be initiated against the bidder.

Bellow 5%	:	No Additional Performance Security
From 5% & above and below 10%	:	50% of (Difference between tender cost put to tender and Bid amount.
From 10% and above	:	150% of (Difference between tender cost put to tender and Bid amount.


6. All the tenders where rate quoted is more than the scheduled rate will be rejected.

7. The bidder who has done agreement with BDO, Samakhunta for other work/works but not completed the work within 3 years of date of agreement, his/ her tender paper will be rejected.

8.. The following Documents should be furnished with the tender paper failing which the tender is liable for Rejection.


- a. EMD duly pledged in favour of the BDO, Samakhunta..
- b. Self-Attested copy of the contractor valid registration certificate.
- c. Attested copy of PAN CARD and GST Certificate.
- d. Money receipt of DTCN (Tender Paper) shall be enclosed in original.
- e. Attested copy of caste certificate for SC/ST contractor desirous of availing preference.
- f. Signed copy of DTCN and price bid duly filled in and signed by the tenderer.
- g. An affidavit regarding authenticity of the credentials.
- h. Name of the Project and Sl. No. will be mentioned in cover of the Envelope.
- i. Mailing address of registered office/site office of the bidders for future correspondence.
- j. P.H Contractor should submit original Affidavit in support of PH certificate (fresh certificate) regarding EMD Exemption.
- K. An Affidavit in support of the authority of documents including no relation certificate should be attached with Tender Paper.

9. Engineering Contractors desiring to avail the exemption facility of EMD should submit an original affidavit as regards, the fact of availing award of work without submission of EMD/ISD during the current financial year. He should also produce original contractor license at the time of opening of tender document to make necessary entry to that effect as such facilities are limited to three participations in tender during a financial year. Otherwise, their tender will be liable for rejection.
10. The SC/ST Contractors desirous of availing preference should submit an original affidavit in support of caste certificate and attested copy of caste certificate, otherwise their tender will be liable for rejection.
11. G.S.T. as applicable shall be paid extra over and above the work value. The Contractor shall however be required to submit the TAX INVOICE along with the R.A. / final bill released of the G.S.T. amount by the department.
12. Shortfall of any required documents, Tender paper is liable for rejection.
13. A bidder can submit only one tender paper for a particular work. Submission of more than one tender paper by a bidder for a particular tender will liable for rejection of all such tender papers.
14. Other details can be seen in the bidding document.
15. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
16. All bids received will remain valid for a period of 90 days from the last date of receipt of bids and the validity of the bids can also be extended, if agreed to by the bidders with the Department.
17. If the L-1 bidder does not turn up for agreement after finalization of tender, then she/he shall be debarred from participation in bidding for three years and action will be taken to blacklist the bidder. In that case L-2 bidder if fulfill, other required criteria would be called for drawing agreement for execution of work subject to the condition, that L-2 bidder negotiate at per with the rate quoted by the L-1 bidder otherwise tender will be Cancelled.
18. The rates to be quoted by the contractor shall be excluding GST. The implementation of the GST rules by the Govt. of Odisha is to be accepted by the bidder at any point of time.
19. The work completed after due period of completion, penalty will be fixed as per the admissible rule.
